# STATIONS OF OUR WAYS

- 1935:** Arnold Nietiedt becomes a master painter in the Ruhr area
- 1938:** Founded as a painting and glazing company in Wilhelmshaven
- 1945:** Destruction of the entire company in the Second World War
- 1946:** After rebuilding the painting business, 20 employees
- 1955:** More than 100 employees and, for the first time, the largest painting business in the region
- 1962:** Entry into scaffolding for external customers
- 1979:** Restructuring of the company into individual companies with specialised areas of expertise in scaffolding, corrosion and concrete protection, and classic painting work
- 1985:** Death of the company's founder, Arnold Nietiedt

## A NEW ERA BEGINS

- 1990:** The start of the branch network with the establishment of subsidiaries in East Frisia, the new federal states and in Emsland
- 1992:** Tom Nietiedt acquires 25% of the company shares
- 2007:** Rüdiger Nietiedt retires
- 2007:** Tom Nietiedt wird Mehrheitsgesellschafter
- 2013:** Tom Nietiedt becomes majority shareholder
- 2025:** Preparations are being made to establish the 'Nietiedt Family Foundation' to ensure the long-term future of the company for the family and the workforce!

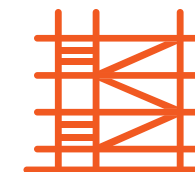
